- 1. Call to Order Recording started and indicated to the members present.
- 2. Declare Meeting Open

- 3. Secretary to Read the previous AGM Meeting Minutes

- 4. Matters arising from the minutes

President's Report for 2024

2023/2024 has been a good year for the Bunbury Radio Club.

Our membership has increased slightly from the previous year. The reintroduction of Assessments has seen 10+ new licensed Amateur operators in the South West Region.

Assessments and Licensing

Led by Norman (VK6GOM) and Bob VK6ZGN, our club has returned to minting new hams. In the last 12 months we have run 2 assessment days at the Mens Shed. Both Norman and Bob have worked to understand the new processes and both have become accredited under the new ACMA volunteer assessors programme. I thank Norman for his years of dedication and service and Bob for joining Norman in this important work. Our club needs new operators to grow and thrive.

Events and Functions

23/24 saw the continuation of our Friday Lunches. Attendance at the lunches has been good and possibly increasing over the last year with an average of 8-10 members in attendance. It is important for our club to share time together to build a sense of community.

The Great Bunbury Fox Hunt 2024 was run in April this year. With 11 attendees, two from as far away as Mandurah, we sent out the hounds on a pedestrian hunt. It was set close by to allow us to get everyone accustomed to the fox and tune in the equipment and skills. The second fox, cunningly set by Anthony was a little further away. Most teams quickly narrowed in on it just in time for the battery to run flat. The situation was quickly rectified by Anthony and the hunt was back on. Most of the teams converged on the final location about the same time. The consensus is that everyone had fun (even those that had the Yagi backwards and ended up in Picton:)) We'll do this again, maybe twice a year when the weather is nicer.

Our Thursday on-air net has been gathering momentum over the last year. With the return of the 2m repeater there has been an uptick in the number of members checking in. I feel the net is an important starting point for new comers as it gives an easily accessible and "safe" place to get their feet wet on the air. I would encourage all members to check into the net regularly and interact on-air with our new club members.

Contesting and Achievements

BRC took out the WIA DX Club Award for 2023. Congratulation to the members of the team (Alek VK6APK, Steve VK6IR, Steve VK6OZ, Phil VK6DEV, Norman VK6GOM, Ian VK6DW, Peter VK6RZ) who took out the competition with a total of 8535 slots. Second was the North East Radio Club on 6326 slots. 2024 is looking promising with the team currently holding a handy lead. I would encourage all club members who are also members of the WIA to register and participate. Every little bit helps and we never know how close the competition might end up being. Join in now.

Individual achievements included, Ian Cook took out the prize Open Grid Prize, Phil Jubb won the Top Score award for Foundation Level.
